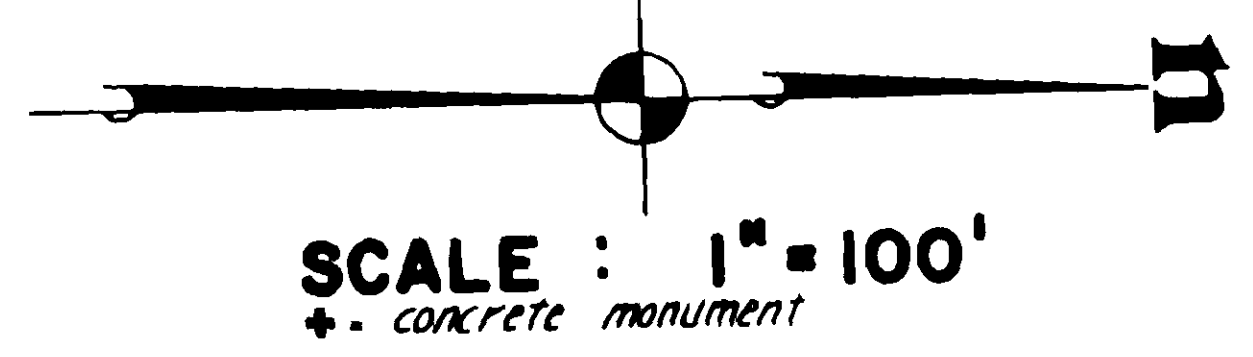

# SHELTER BAY DIV. I

## SECTION 36, TWP. 34 N., RGE. 2 E., W.M.

### SKAGIT COUNTY, WASHINGTON

#### DESCRIPTION

This plat of SHELTER BAY DIV. I embraces a portion of Government Lot 10 and of the NW 1/4 of the SW 1/4 of Section 36, Township 34 North, Range 2 East of W.M. in Skagit County, Washington, described as follows:  
Commencing at the west quarter corner of said section; thence S 1°07'11" W along the west line of said section 656.82 feet to the north line of the south-half (S 1/2) of the NW 1/4 of the SW 1/4 of said section and the POINT OF BEGINNING; thence N 89°32'08" E along said north line 657.73 feet; thence S 1°10'48" W 654.83 feet to the north line of said government lot; thence S 1°07'11" W along the east line of the west-half (W 1/2) of said lot 578.06 feet; thence S 88°16'00" W 518.23 feet; thence S 32°16'00" W 269.14 feet to the west line of said section; thence N 1°07'11" E along said west line 1470.84 feet to the POINT OF BEGINNING.

#### CONSTRUCTION AND MAINTENANCE OBLIGATIONS

The cost of construction and maintenance of all roads not herein dedicated as County roads and all access roads to the plat, unless the same are dedicated as county roads, shall be the obligation of all of the owners of the lots in the plat and/or of any additional plats that may be served by said roads, streets, and/or alleys, and that the obligation to maintain shall be concurrently the obligation of any corporation in whom title of said roads, streets, and/or alleys be held. In the event that the owners of any of these lots or the corporate or private owners of any of the roads, streets and/or alleys of this plat or any additional plats served by these roads, streets, and/or alleys shall petition the Board of County Commissioners to include these roads, streets and/or alleys in the road system, said petitioner shall be obligated to bring the same to the County Road Standards in all respects prior to acceptance by the County.
