



Did you know that our Marina has received Clean Vessel Act grant funds since 2016? The *Clean Vessel Act of 1992* established funding for the construction, operation and maintenance of sewage disposal systems serving recreational boaters. 75% of construction costs for our "Pump and Dump" sanitation station was offset by funds from the Wildlife and Sport Fish Restoration Program, available through the Washington State Parks Clean Vessel Program. We submit annual reports on usage and receive reimbursement for 75% of eligible operating costs.

Our floating pump-out station is located north of A Dock and east of the boat launch in the main basin of the Marina. It's accessible only by boat and is available to any recreational boater, not just Shelter Bay Marina tenants.

#### **Winter Driving Supply List**



Accidents, flooded roads, pass closures and other winter events can mean unexpected time in your car. Be prepared. Pick up these items on your next shopping trip and then pack them into your vehicle.

Keep a basic winter survival kit which should include a flashlight, extra batteries, blankets, nonperishable food/snacks, water, gloves, hats, scarves, boots, and a first aid kit.

Washington State law **requires** vehicles weighing 10,000 pounds or greater, including some large SUVs and RVs must install chains when traction tires are required. All vehicles, except 4WD and AWD, must put on chains when tire chains are required. However, **4WD** and AWD need to carry chains in order to proceed across the pass. Also, carry a cell phone charger/battery booster, ice scraper/snowbrush, jumper cables, flares or a warning triangle, kitty litter or sand to help with traction and a whistle to signal for help. If you find yourself stuck or stranded, stay in your car, put on your flashers, call for help and wait until it arrives.

#### Manager's Report

Thank you, Shelter Bay Community for the opportunity to serve as your Interim Community Manager. Carol and I have lived in Shelter Bay for over 12 years now and we love it here. Shelter Bay Community is short-staffed right now. If you know of individuals looking for positions in accounting, maintenance, or management, please let the office know. Please consider volunteering for a position on one of our great committees. Our staff is doing an admirable job of keeping up. We made it through the snow and cold with only two small water leaks, one pump station failure and the sander stripped a gear. Our plowing crews were on top of the snow the whole time and if you were out away from Shelter Bay, you realized our roads were the best. Good job crew! Our huge marina project is in its final phase. American Construction will complete the dredging between Christmas and New Year's. Our harbor now has a consistent elevation of minus 9. Approximately 40,000 cubic yards of material was removed. We apologize for the noise in the early mornings. It was unavoidable. Marine Floats has arrived with all the components for the new F thru I docks and has begun assembly. J dock, which was replaced by Marine Floats after the fire, was removed for the dredging, put in the North basin and is now back in place. We hope to be moving boats back within the next few weeks. The true nature of a community can sometimes get blurred but the old saying "actions speak louder than words" is so true for this community's accomplishment of a 6-million-dollar marina project. Congratulations to all of those involved. Marina staff is working on a marina dedication and christening early in 2023. Wishing everyone a joyous and Happy New Year. - Pat McGarry

#### **Rainbow Park: New Beginnings**

Many hands working together completed the Replanting of Rainbow Park on December 15. Award winning senior botanist for SRSC, Brenda Clifton, prepared the site with native plants, including Douglas Fir, Pacific Madrone, and Shore Pine which is native along Washington's coast and previously successful at the park. Volunteers helped put plants in the ground, then later more people gathered to hear Pastor Doug York's blessing and Mr. Kevin Paul's drum songs. Wood chips will soon provide mulch, and informational signs will line the short path to complete this "new beginning." Over the next few years Clifton will tend the plantings to ensure as many survive as possible, expected to be about 50%. Thanks to all who were able to join this day and remember to watch for a larger celebratory event in the warm spring.






