Manager's Report

I was daydreaming the other day and thought how great it would be to have the Shelter Bay side of the Rainbow Bridge outlined in lights like the La Conner side. I would bet we could do a "go fund me" campaign and get this done. Anybody interested in taking up the charge? Count me in as donor number one on that project.

Typical of year end and the beginning of a new year, the Shelter Bay Community office is very busy. The Shelter Bay office is no longer on restricted hours and is open 8 to 5. I can't say enough for the very hard working and dedicated staff we have. Shelter Bay Community has 12 employees. This staff manages approximately 835 homes, 11 miles of roads, a sewer system, a water system, greenbelts, parks, golf course, a marina and read 1000 water and electrical meters. In addition to 1000 other small chores. Compared to other communities, Shelter Bay is very efficient. This could never be done without unbelievable group of volunteers who come in day after day to help "keep the lights on." Our committees are always looking for volunteers. Please consider joining one of Shelter Bay Community's great committees.

In my previous career, I asked our company president why we were spending so much money on expensive new equipment and rebuilding old equipment. This was during the "turn the lights out in Seattle" time. He said business never stops, it either advances or declines, it never stays still. That company grew from a small Northwest construction company to the third largest in the United States. I guess he had something there. So, when you see work going on in Shelter Bay don't think we are spending money recklessly, we are just trying to keep from going backwards. This is particularly relevant during this budgeting time to realize this. We have some very aging infrastructure that needs addition and some facilities that are seriously out of date and no longer viable.

This is a subject I would prefer not to bring up, but I must. Recently we had instances where community members have directly threatened Shelter Bay Community employees. This will not be tolerated and have referred these incidences to police. There are processes to go through if you have concerns about Shelter Bay employees, policies, or decisions the community has made. Our hard-working employees do NOT deserve this, and it will NOT be tolerated, ever, period.

By the time you read this, our new marina will be complete. What a beautiful site! My sincerest thanks to those early on and now that have seen this through. This accomplishment testifies to the fact that Shelter Bay is a great place and do great things.

A decade's worth of planning and work is wrapping up this month as the final phase of the Marina Improvement Project is completed. This achievement is possible because of the vision and effort of Shelter Bay volunteers too numerous to name here. From concept to strategy to implementation, the Marina's new docks and dredged harbor are a testimony to the Board's commitment to increase revenue for the Community while improving an asset for all members.

The contractors responsible for this last phase of work - American Construction for dredging and Marine Floats for docks - provided exemplary service and completed work ahead of schedule and on budget. Marina tenants will begin moving into new slips this month and you'll see us continuing to make shoreside improvements at F-I docks over the next few weeks. With the end in sight, we're planning a completion celebration on **February 18th from 2pm – 4pm, at the BBQ Pavilion**. You're invited to join us around the fire for a cup of chili as we toast the end of this project.

The Rules & Seasons of Martha's Beach

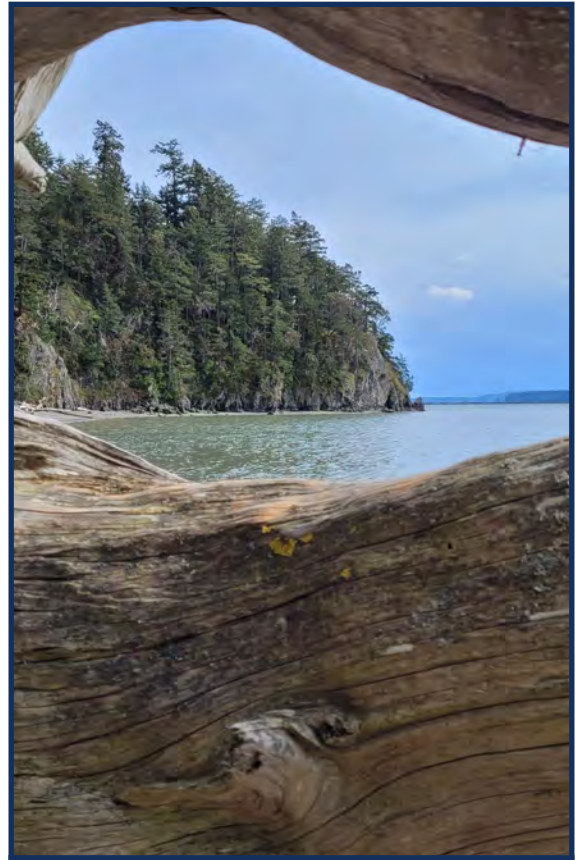
Per the Shelter Bay Community **RULES AND REGULATIONS,**
PART I – GENERAL, page 5.

5.10 Martha’s Beach.

- a. The hours of use at Martha’s Beach are 8 a.m. to 7 p.m. from October 1 to March 31, and from 6 a.m. to 10 p.m. from April 1-September 30. Overnight use of the beach property is prohibited.
- b. Operation of vehicles and motorcycles on Martha’s Beach, other than transportation to and from, is prohibited.
- c. Dogs may be allowed off-leash on Martha’s Beach so long as the owner maintains complete control and picks-up after them. If requested by a community member, the owner must put dogs back on leash.
- d. Removal of driftwood from Martha’s Beach is prohibited.

Martha’s Beach gate is opened by our maintenance staff in the morning and closed by our contracted security folks in the evening. In the event of something that requires closing Martha’s Beach, we rely on notification from residents, our maintenance staff, or our security personnel. Occasionally, due to schedules, the gate may not open or close at the specified times.

Martha’s Beach may be temporarily closed due to snow, high/King tides, Tsunami warning or any reason the beach or water may contribute to a safety hazard for our residents and their guests. This area is considered a Shoreline and Sensitive Area (SSA), which may require a permit to clean up debris. Staff works with the Swinomish Tribe to provide a safe place to enjoy the water and views of Martha’s Beach.

Last summer several residents formed Skagit Valley Clean Energy Co-op, a volunteer-run nonprofit, to help locals install solar panels and battery storage. [Olympia Community Solar](#) is working with SVCEC to assist groups in Skagit, Thurston, and Mason counties.

This is a simplified way to get solar on our homes, helping us by taking the legwork and guesswork out. This is a buy-in-bulk approach to bring solar to us at a reduced price; they will have vetted solar installers, so we don't have to.

We get a 30% tax credit and lower energy bills. This opportunity is a win-win situation. Plus, a local 'green' bank is available for low-cost financing.
