This year the Board has approved an additional budget meeting on March 30 if more time is needed to finalize the draft. The draft of the budget will be based heavily on the current year and each Committee will submit their request for funds for the coming year for upcoming projects. The Manager, with much assistance from our accounting department, will provide a draft to the Finance Committee and Board of Directors for review. The \$1,725,000 loan from Peoples Bank closed last month. Proceeds have been deposited into Shelter Bay's checking account. The current goal is to pay off the 10-year loan in 5 years. Payments will be made using marina income, which also helps to pay for part of the annual lease. Excess income, if any, will be put into reserves.

## Manager's Report

Looking at the weather forecast doesn't give me much hope for an early summer but the marina christening we had last week had a great attendance. The wonderful chili, champagne, big fire in the BBQ pit and friendly conversation helped shake off the chill. Thank you to all who helped put it on. Our new marina is now officially christened with Debbie Byrd, our past Executive Secretary doing the primary ribbon cutting. As I write this, our Board members are off to signing the final marina loan documents. This will put the community reserves back up to where the Board of Directors wanted them to be after the final phase of the marina project. It is hard to believe we have been working on this for over 10 years and it is done!

Staff and finance committee are putting budget numbers together for next year. There will be several community budget meetings coming up in the next few months so keep an eye out for them so you can give your input. You can also email the Board of Directors with budget questions or suggestions. Another opportunity for input is at the Town Hall meetings which typically take place on the Sunday following the Board of Directors meeting. They are usually scheduled for Sundays at 7:00 pm which provides an opportunity for everyone. These Town Halls allow any community member in good standing to express themselves on community affairs.

I know many of us would like to have a dog park and we still have it on our minds. We have not been able to find an adequate spot that meets all the requirements. The sites that have been identified either lack parking, have drainage issues, neighbors too close etc., etc. Keep in mind that Martha's Beach is an off-leash area. We did relax the off-leash enforcement for a period of time but until we have located and established an alternate off leash area other than Martha's Beach, we will be actively enforcing the on leash requirement again beginning March 1<sup>st</sup>.

There is every indication that we will have a new permanent Community Manager on staff by mid- March. I believe the selection committee will be making that announcement soon. It has been a pleasure to have served as interim manager for the last few months. This is a great community and I thoroughly enjoyed being involved in that capacity. My plans are to stay involved in the marina with so many other wonderful Harbor Committee volunteers as well as daydream about lights on the Shelter Bay side of the Rainbow Bridge, upgraded pool and golf carts in Shelter Bay. Thank you to the great Shelter Bay staff and the community for their support.

## Did you Know?



**DID YOU  
KNOW?**

Community members are asking why we no longer record and post meetings on our website. The Board reviewed this with our community legal counsel and she was very clear with her response. Shelter Bay meetings may not be recorded. Washington law prohibits recording conversations including private meetings without all attendees consent (RCW 9.73.030). The free exchange of ideas and information is best served in this environment. Why not ask for everyone's consent? Again, the policy is to facilitate the free exchange of ideas and information in a business environment. The very idea of recording or putting any one person on the spot under pressure to consent or not consent can create a sense of a hostile environment. That does not facilitate a collaborative working environment in which to get business done.

- 6) Approved to Sanction Director Judy Kontos by suspension pending a recall vote of the Community for four violations of Chapter 40.020.010 – (x 2) Failure to Support the Decisions of the Board, 40.020.020 (x 2) Dissemination of Confidential Information, and set date to be determined before the March Board meeting.
- 7) Approved to reject Director Dan McCaughan's Appeal to the Board, the Ethics Committee findings.
- 8) Approved to Sanction Director Dan McCaughan for violation of Chapter 40.020.010 for Failure to Support the Decisions of the Board with a 90-day suspension from all Committee duties and provided notice that any further violations against the Code of Conduct would result in continued sanctions.

The Turkish earthquake reminds us that our Earth is mobile and unstable. Television seizes on disaster, highlighting death and destruction. How can we put another concern into perspective?

Disasters are rare but possible: earthquakes, floods, storms, long-term power outages and on and on. These need not be concerns added to your worry list if you've made plans for yourself and your family. Plan templates abound, pamphlets and booklets in the Shelter Bay office, even more online. Your disaster plans don't need to be complicated because there are simple actions to take before, during, and after a disaster which work well. When the Big One occurs then panic has already been displaced by your Plan - you know what to do.

Disasters are situations where the event overwhelms the usual emergency responders' capability to help. You can also help yourself and others by joining a Community Emergency Response Team. (CERT) This free training for dealing with disasters enables you and your neighbors to bring basic responder skills to situations where normal help is unavailable. Shelter Bay has an active CERT program which is an effective way to help you make a Plan. That's the way to put disasters in perspective!
