## BUDGET DEVELOPMENT MEETINGS

Our fiscal year starts on July 1, and this is the time of the year to start creating the budget for Fiscal Year 24/25. In addition to operations, there are significant funds dedicated to capital projects. The process starts with the Operating Budget, and then the Capital Budget, which is drafted by the Manager and is heavily based on the current year. The Manager will provide a draft to the Finance Committee and the Board of Directors by Friday, March 1. In the following weeks, there are three budget development meetings scheduled to review and revise the draft.

March 7 – 1 p.m. – 4 p.m. - Operations

March 19 – 1 p.m. – 4 p.m. – Capital

March 26 – 1 p.m. – Optional, as needed.

The third budget development meeting on March 26 will be held only if more time is needed for discussion.

These meetings will be held in the Clubhouse and via Zoom, they are open to all members of the Community, and we are asking for your participation. If you cannot make the meetings, we would appreciate any input you wish to share. 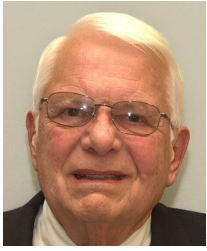

## President's Message



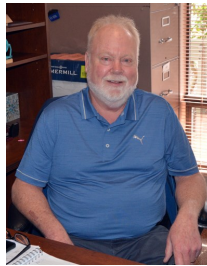
It's hard to believe that it's February already. January gave us some winter weather to try out our generators, snowplows, and rain gear. It was fun to see the kids sledding on the golf course and building snowmen. Hopefully, our homeowners and marina tenants didn't have too many frozen water lines. The Shelter Bay Maintenance staff and Harbormasters were busy answering calls and being proactive in the freezing weather. Thanks to all of them for their good work.

The Board Meeting and Town Hall meetings did a good job of taking care of January's business. I'm a big fan of the new format of the Finance Reports. The reports are easy to understand and even entertaining. A tip of the hat to Joseph Elkins, our Controller, who puts these presentations together. I would also invite you to attend our Town Hall meetings the Sunday after each Board Meeting. The next meeting is February 25, 2024, from 7-8 p.m. in the Clubhouse in-person only. These meetings are casual and very interactive.

There is not much to report on New Lease progress in January. We still haven't heard from the Bureau of Indian Affairs about a joint meeting with the Swinomish, BIA, and Shelter Bay New Lease Groups. I am hopeful that this meeting will happen in February.

As a final item this month I'd like to share something I found out. I like to receive my communications with Shelter Bay via email including my bill. I noticed that we send out a lot of newsletters and bills using USPS. This is labor-intensive and expensive. So, if you are currently receiving your newsletter or bill via the postal service and would like to use email, please contact the office. Currently, you can't use the website to manage your choices, but our new system will eventually allow you to manage this yourself.

## Community Manager's Report



Greetings from the Shelter Bay Community Office

**Pool Update** – We are excited to announce that, on Thursday, January 11, we received an operating permit for the pool. This is a temporary permit issued by the Swinomish Permit Department with the understanding that we will be continuing with the major renovation of the pool and exterior decking areas that I shared in last month's newsletter. We are currently looking at long-range weather to see when the best dates and times to open will be. This will be a short-term opening as we then move into the Renovation Phase. More to come.

**Playground update** – As previously reported, we identified a few additional permitting issues that need to be addressed related to a Wetland Study, along with a Liquefaction Study. We hope that those studies will be completed by early February, allowing us to install the equipment in Early Spring.

We received our first winter weather in the third week of January, and it was my first experience with it here in the community. There was quite a bit of snow and some ice. Our staff worked diligently to plow the roads, and to sand those areas that do ice over. We have also identified some specific areas that are more problematic than others and tried to focus on those as much as possible to ensure safe travel for all our members. I continue to collaborate with Staff and committee members to try to resolve those areas that pose major challenges, and to get fixes in place as soon as possible. It is my understanding that some of these issues have lingered on, and we will do our best to cure them as quickly as possible.

On Tuesday, January 9 we had a power failure here in the community and this caused challenges with our water system. When the power failed, our backup generator that powers the water pumps kicked in right away, but the power from the generator to our pumps was not transferred over immediately. This resulted in a loss of pressure in the water system while we worked on the transfer, which in turn created the "Boil Water" issue. The technician from the Generator Company was on site quickly and was able to get it switched over, but, due to the loss of pressure, out of an abundance of caution, we issued the boil water notice. We now have staff members who know what to do in the event the generator does not transfer over right away, so we do not anticipate having the same issue in the future. Additionally, I have made some inquiries with the lab that processes our water testing, trying to expedite results, and I will be visiting the lab to have more discussion regarding the timeliness issue.

As always, I want to acknowledge all the staff at Shelter Bay. They are a hard-working group of talented individuals who do their very best to serve the community. I also thank all the volunteers, Committee members, and Board members who contribute their time and expertise to help make Shelter Bay a great place to live.

## Volunteerism - Part 2

Last month we touched upon our desire to assist others in a time of need. This is volunteerism, and for volunteers to be most effective they need to be organized and guided. Have you reached out to Gary at [fd13cro@wavecable.com](mailto:fd13cro@wavecable.com) and given him your contact information and areas of interest to provide help?

The severity and extent of a disaster could be such that Fire and Police will not be able to receive our distress calls, and/or may not have the personnel to provide timely response. This means Shelter Bay needs to be self-reliant for some period of time. Your Community Emergency Response Team has already made extensive efforts for such a scenario by outfitting a Disaster Assistance Center (DAC) in the Storage Lot. Now is the time for volunteers to be trained in running the DAC, which includes setting up tents with heat, triage, shelter, supplies, etc.

Additionally, HAM radio operation training will provide vital communication, and volunteers will be trained in assessing and reporting neighbors in need. This effort is supported by "Help/OK" signs, available at the office, and which every home is encouraged to have. Other training includes Traffic Control, personnel accountability, and medical support.

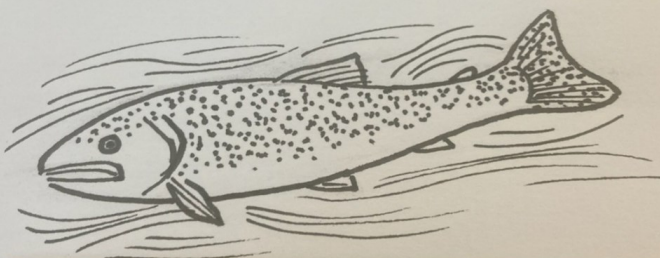
### 13 Moons

#### Moon of the Windy Time

Some of you have had the great fortune of hearing about 13 Moons. Swinomish is currently in the 'Moon of the Sacred Time', (late Dec./Jan.), which is both the final moon of one yearly cycle and the beginning moon of the next cycle. This is a time for renewal and rebirth. Thus, it is also the perfect time for learning spiritual and cultural traditions from elders around the longhouse fires.

Sea-run cutthroat trout, blackmouth salmon, and steelhead are fished during winter moons; duck, geese, deer, and elk are hunted; and tools, baskets, and other items are constructed. Shellfish are collected during the nighttime low tides. This was kindly shared with our community by Michal Heidt, Coordinator of the Swinomish Community Environmental Health Program. 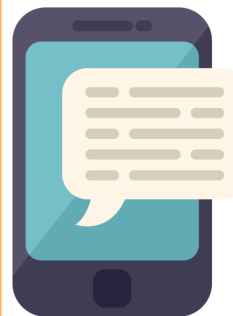
## Shelter Bay Drive Electric System Upgrades

February traffic may be down to one lane, so leave a little earlier in anticipation of a wait on Shelter Bay Drive itself, as well as when entering Shelter Bay Drive from any side street between the two ends of Swinomish Drive - basically from the front gate to the start of the golf course.

**Why?** PSE and Potelco electric crews will be here to replace underground electrical cables that provide electric service to our community. They will be replacing these cables on Shelter Bay Drive between the two ends of Swinomish Drive. The civil construction crew (trenching/laying conduit) anticipates beginning the first week of February, working February 5-15. The line construction crew (pulling wire/connecting) anticipates beginning the week of February 26, working February 26-27. According to a letter mailed to PSE customers, project duration could vary based on inclement weather and emergency crew assignments. Work hours are typically Monday through Friday, 8 a.m. to 4 p.m.

If you haven't yet sent this text message, you may want to. This will enable you to receive community text messages from the Swinomish Tribal Community. Once you do so, you will then get to receive their bulletins and events via text message. Now, please keep in mind that most of their announcements are solely for tribal members, but not all of them. They often have great weather and safety text messages that affect us. In addition, there are periodic events that are open to the entire community. It will also give you some interesting insight into what activities are going on with the Swinomish Tribe. The text messages will generally specify if it is an open event. Open your text message application, type 91896 as your recipient, then Swinomish1 as the message, and send. You should receive a message from Swinomish Tribe's TextMyGov notification list asking you if you would like to join. Reply Yes, to check it out!

## Rainbow Bridge Lighting

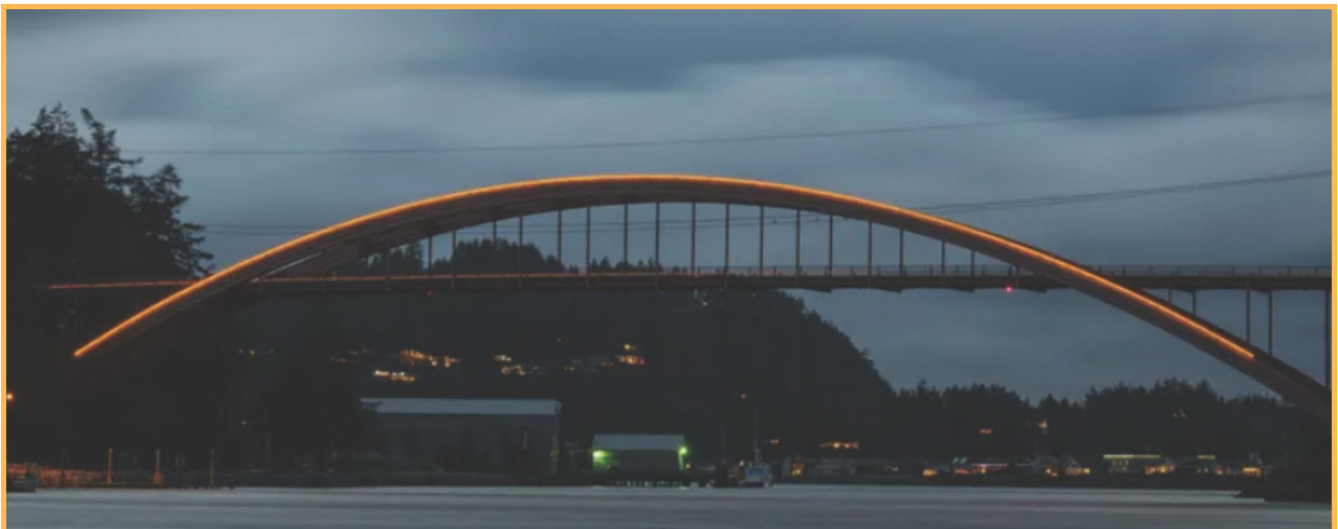
Rainbow Bridge is the most significant feature of the visual character of the Town and Shelter Bay community. For those of us who are privileged to live here, the lighted Bridge signifies "Home."

The Shelter Bay "Light Brigade" has been formed to fund the permitting, installation, and maintenance of lights on the south side of the Bridge in partnership with the Town of La Conner. Employing the same process and technology used by the Town, we can create a unified look to the Bridge, reinforcing the close bonds between Shelter Bay and the Town.

This project will be funded entirely by private donations, placing no financial burden on the Shelter Bay Community other than minimal annual maintenance costs. Our budget is \$20,000. We seek your pledge of financial support through our "pledge now, pay later" process. Pledges will demonstrate support in our negotiations with partnering agencies, payment later (probably September) will fund the permitting and installation. We have received numerous pledges of \$500. Any amount is welcome.


