President's Message



The Shelter Bay Community Annual Meeting provided the opportunity to elect three existing board members to new three-year terms and elect a new Reserve Director. **Wendy Poulton, Pat McGarry, and Monte Hicks** will continue in their current director roles, and **Julie Peddy** will be available to step in if we lose a current board member. Thanks to all of them for providing a continuity of governance that makes the board's work much easier.

The Annual Meeting also provided the opportunity to showcase last year's accomplishments. These were two-fold. Our financial performance was outstanding as was our operational performance. Please read **Bill**

Palmer's, Community Manager, message for some highlights. Shelter Bay Community's success results from the work of a dedicated group of volunteers and a professional staff that keeps the train on tracks and running on time.

My belief is that "The past is prolog" and we must keep moving forward. So, last year was good, but our job will be to make this year even better. My primary job is to keep up the pressure on getting a new long-term lease for the residents of Shelter Bay. I must admit that I am currently frustrated by the lack of progress during the last two months. Our group met with the Bureau of Indian Affairs over two months ago, and we have not received a response to our proposal. I've had this kind of frustration, in the past, when I've had difficulty accomplishing a goal. I found myself asking, "What could I have done better?" Not long after dealing with this self-doubt, there was often a breakthrough. Let's hope this happens now.

I want to mention a newly developing relationship. The Mayor of La Conner, **Marna Hanneman**, and I have agreed to have regular meetings. These meetings include La Conner's **Scott Thomas**, Administrator, **Brian Lease**, Public Works Director, Shelter Bay's **Bill Palmer**, Community Manager, and **Lawson Earl**, Project Manager. Shelter Bay and La Conner are codependent. Good communications are essential for a healthy economic development environment.

Shelter Bay Community will honor our volunteers on Wednesday, June 26. The event will be at the Clubhouse from 3-6 PM. If you're a volunteer, I'll see you there. If you're not a volunteer, join a committee and help keep Shelter Bay the unique community it is.

Community Manager's Message



We recently held the Shelter Bay Community Annual meeting. I recall last year's annual meeting when I had only been in my position for a little over 2 months and quite honestly was still trying to absorb all the various facets of the Community Manager position. Now that a year has passed, I am much more comfortable in the role and much more knowledgeable regarding not only the requirements of the position but also all the various projects that need to be addressed. Below are updates on several of those items.

Pool Update – On April 25 we received permits to move forward with the refurbishment project. Upon contacting the vendors that will be performing the work we found that they were no longer able to put our project in their upcoming schedules. Therefore, we decided to keep the pool operational for the rest of the spring and summer and will begin the project on September 3. We have changed the hours to 9:00 a.m.-8:00 p.m. and will continue to review and change if necessary. My thanks to all our staff members in Maintenance and the office who contributed to getting the pool operational. **As a reminder, no animals in the pool area please!**

Playground update – In the first few weeks of May we met with members from the Swinomish Planning and Environmental Protection departments along with a representative from Hamer Environmental to discuss some of the new wetland buffer requirements that the Planning Department had shared with us. We were advised that there was additional information that we needed to provide related to an area next to the wetlands. We have engaged Hamer Environmental to do this work and as of this writing, the work is tentatively scheduled for the first part of June. Unfortunately, until this is completed, we are not able to move forward with the installation of the new playground equipment. We continue to push forward on this and will make every effort to get this completed as soon as possible. We appreciate everyone's patience as we work to satisfy all parts of the permitting process.

Coquille Park – The Board recently approved plans for renovating the old pool building to include installing a handicapped-accessible bathroom, finishing out other areas of the building for potential meeting space, and updating all the sidewalks around the exterior of the structure.

Roads/Pavement – We are currently working on timing for repaving the Marina parking lots. We will also be working on some of the roadways deemed to be in the worst condition based on a recent pavement assessment. We are also putting together a plan/schedule for the line painting of all the roadways and will share that as soon as it is finalized. As mentioned in my last article we plan to add reflective beads to the paint when we do the striping to make the lines easier to see at nighttime.

DNR Grant

Welcome to the world of Grant Writer, Shelter Bay Committee Secretary, Renata McCauley. She learned that the Department of Natural Resources (DNR) had a micro-grant to apply for and the community could get \$4,000 if Shelter Bay spent \$4,000 on Firewise work. She applied, the grant was approved, and the Green Committee has spent over \$4,000 on Firewise work in greenbelts. There was a requirement to host a community event to educate residents about wildfires and how they can increase ignition resistance through homeowner mitigation actions in the Home Ignition Zone (keep your lot cleaned up, etc.). This requirement has to be completed and submitted before June 20, which Renata will do.

Renata is also working on getting Shelter Bay Firewise Certified again since we lost our certification due to management changes. Part of completing the certification is having a Firewise Action Plan, which Renata secured; educating the community on May 16; and getting a Risk Assessment, which will be done this Fall with help from the Skagit Conservation District.

Update: A letter was received by Renata from the Department of Natural Resources as the deadline for the newsletter arrived reading "I would like to congratulate Shelter Bay Community, Inc. on its successful application; you are being awarded the requested amended amount of \$10,000. As mentioned in your project narrative these funds will be used for the following deliverables: Grant Funds would be used to hire the contractor to clean up the areas that need Firewise work."

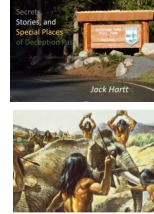

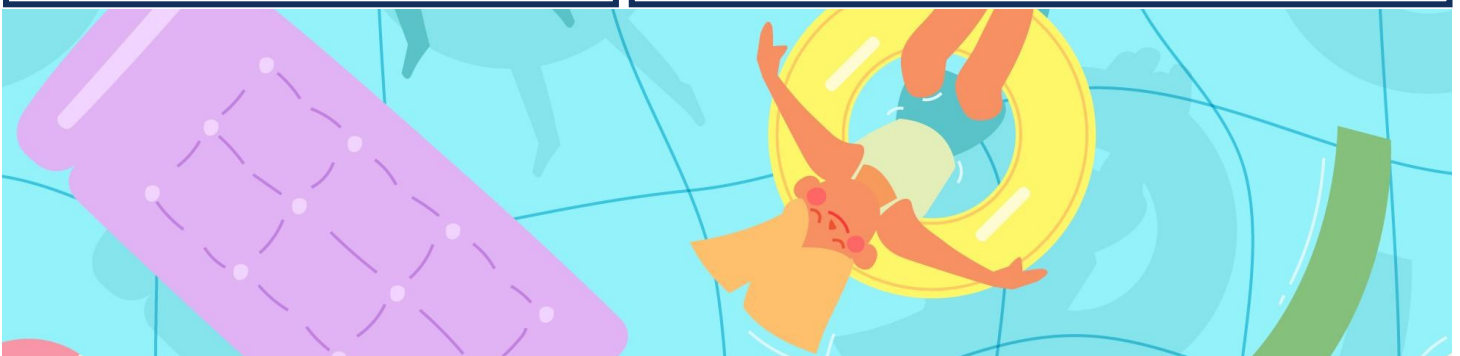

A note from your ACC Chair – Alan Dietz

As the weather becomes warmer thoughts of spring projects begin to bloom. Thoughts of deck repair, replacement, power washing of decks and driveways, gutter cleaning, exterior painting, and new fences. This is a reminder an Application for Shelter Bay Construction Certificate of Compliance is required for major construction, major remodeling, variances for fifteen-foot height restriction, front, side, and rear yard setback distances.

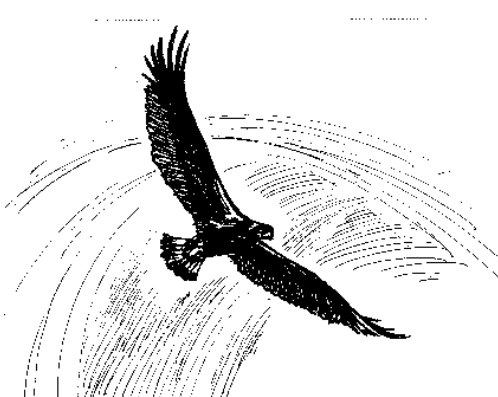

Minor construction projects such as new outbuildings, greenhouses, and sheds, exterior siding replacement, doors or windows replacement, and new or replacement exterior light fixtures are required. Site Work - projects requiring excavation, grading or backfill, construction of hardscapes such as driveways, walkways, patios, retaining walls, stairs, and pads consisting or having surfaces of gravel, stone, asphalt, or concrete, and for other on-site projects including ditch maintenance and excavation and backfill for grading or drainage projects. New or replacement of decks, fencing, exterior painting, repainting, roofing, re-roofing, propane tanks or heat pumps, and private docks require a Certificate of Compliance. This also includes temporarily using a motor home, trailer, or boat as a living quarter during construction. All the information can be found at shelterbay.net – resources – Shelter Bay Construction Guidelines and Forms. For those of you who are maintenance warriors, remember that ladders are one of the major causes of serious accidents and injury along with eye injuries. So, be careful and safe out there as you attempt to clean the gutters or roofs, power wash the driveway and decks, change light bulbs, prune trees, or paint your home.

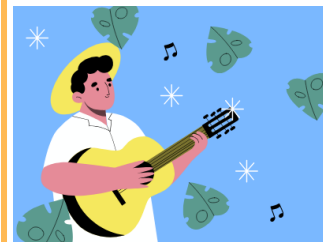
