Community Manager's Message



Pool Update – Now that weather has begun to improve, it has allowed parts of this project to move forward. This includes the pouring of the pool deck, installation of the fence and gate, and more recently the installation of pool tiles. The crew has also been working on the pool equipment that will now be located outside the clubhouse building. We anticipate this continuing to move forward more quickly with the weather improving. We hope to have the plastering of the pool done sometime soon as well as the pouring of the decking and sidewalk surrounding the pool area.



Playground — As mentioned last month, we have come up with a potential new course of action for the new playground equipment. We are still working through all the details and will share more information as soon as possible.

Marina – The Marina operation continues to have very high occupancy, and continues to come in better than budgeted month after

month. As mentioned last month, we did have the Boat Launch rekeyed, and encourage anyone with a boat launch key to contact the office to swap their old key for a new one.

Maintenance Department – The Maintenance Department continues to work diligently on various maintenance issues throughout the community. They have now installed approximately 130 of the new drive-by water meter tops. We also recently received the laptop that is used in conjunction with the meters, and over the next month or so we will begin to do some of the reads via the drive-by method. We will continue to switch out the remaining tops over the next month or so, and have recently asked the vendor to deliver all the full drive-by meters (tops and bottoms) so we can begin the process of installing those. We recently had street sweeping service in and had two vehicles sweeping throughout the community, getting rid of all the leftover debris after the snow and sanding that occurred this winter. We have a variety of other projects that the team will be working on as we move into the spring and summer months.

Roads/Pavement— Now that winter is over and the streets have been swept, things are looking much better. However, there are always going to be areas that need attention. We encourage you to report any potholes or other road-related issues to the office so we can ensure they are reviewed and addressed by the Maintenance Team. We are also currently planning for the coming year's various paving projects throughout the community.

Golf Course— Now that the weather has begun to improve, we have started to spend additional time on the golf course. We recently started to mow the course and, as mentioned in prior articles, we plan to do more work on the greens this spring. We are also looking at addressing the tee box/platform areas to freshen those up, and will make sure irrigation is working properly as we go into the warmer months. The goal is to make the area look better and be more enjoyable for those that use the facility.

The Board held a Company work session to review all lease-related matters and will continue to keep the Community updated as progress is made. We understand the process is long, but it won't be long before things begin to ramp up, and we'll share that along the way.

The Board has appointed a Bank Stabilization Task Force, which will develop a process for analyzing any work request within the Shelter Bay shoreline, similar to other requests such as a view request or an Architectural Construction request. We are looking to have this work completed by June.

We also want to thank Community Manager Bill Palmer and his staff for their work. Bill has been with us for two years now, and the improvements to the Community under his tutelage are greatly appreciated.

Earthquake! Did you feel it?

On March 3, many of us were rudely awakened at 5:02 a.m. by a magnitude 4.5 earthquake, whose epicenter was located on the east side of Orcas Island, just 20 miles away. Lucky for us, the shaking lasted only 20 seconds. But if the shaking had gotten stronger until your house was really rocking and rolling, *would you have known what to do?*

We live in an area crisscrossed with faults, where movement by rocks on opposite sides of the fault will produce an earthquake. The Orcas quake should be more than a morning wake-up call. We know that large and small earthquakes will occur, but we don't know when.

The Safety Committee strongly recommends that you have a basic plan in place to respond effectively to the next earthquake. Go online, search for 'Earthquake Preparation', and everything you could possibly need for planning, from simple to complex, is laid out for you. I recommend <https://www.ready.gov/>.

You can also sign up for a program called ShakeAlert, which will provide you with anywhere from a few seconds to a minute's notice that an actual earthquake is on the way, depending on your distance from the epicenter. The more distant the earthquake, the more warning time.

Skagit County Fire District 13 is now producing a 4-page quarterly newsletter. If you'd like a copy, stop by the Shelter Bay Community Office. Fire District 13 serves a total of over 7,000 residents across a 71-square-mile area, including Shelter Bay Community, while the La Conner Fire Department serves approximately 900 residents within the town's boundaries. Smoke Alarms

Fire District 13, in partnership with the American Red Cross, can install a smoke alarm (including hearing-impaired alarms) and create a customized fire escape plan for your home at no charge.

The smoke alarms they install are suitable for approximately ten years. FD 13 can help replace 9-volt batteries when the batteries need their yearly replacement. Hardwired smoke alarms with battery backups should have their batteries replaced annually or when the alarm starts to chirp.

Compliance Corner

Hey Shelter Bay! It's officially the end of hibernation season and spring has sprung! I hope everyone is enjoying the longer days and sunshine. A couple of issues I want to put on the Community's radar screen...

As some of you may already know, there's been a lot of discussion around exterior lighting in the Community as of late. I want to remind you that our Covenants state that any exterior lighting requires written permission from the committee responsible (i.e., the Architectural Compliance Committee). Our Rules & Regulations require that exterior lighting (which would include string lights) is downlit and utilizes low light levels. This applies to string lights, which I know are quite popular around here; however, in most cases string lights do not meet the requirements of our Covenants in that they do not include diffusers, deflectors, or an arrangement that diffuses the light. The ACC will be contacting residents with non-compliant lighting, so I wanted to provide a head's up and encourage residents to get ahead of this if you have installed any exterior lighting without a permit. Applications can be found in our office or on the website.

Another issue I want to bring attention to is dogs being leashed and picked up after. Our Rules & Regulations require that dogs are leashed at all times. Unleashed dogs can bite humans or other dogs, cause residents to fall, and cause larger issues if another reactive dog is present. If you would like to let your dog off-leash, Martha's Beach is a lovely spot I recommend visiting! It is equally important that dogs are cleaned up after, which does not include throwing your dog's poop in the marina (yes, that happened!). It may seem like a small thing, but it keeps our community clean and shows respect to your fellow community members. Having your dog off-leash anywhere except Martha's Beach and/or not picking up after them will result in a warning, and subsequently a fine of \$100.00.

Dock Notes April 2025



Spring is finally here! With longer days, warmer weather, and the beginning of the sport fishing season, marina activity is heating up! Marina staff will soon start engaging in spring cleaning by pressure washing docks and piers. With the welcome return of marina tenants, there will be more vehicles in the marina parking lots. This would be a good time to revisit our parking guidelines.

- Vehicles parked overnight at the Marina shall display a parking permit decal. Marina parking includes these areas:
 - near the boat launch & A Dock
 - at C/D/E Docks
 - along Shoshone Drive at F – J Docks
 - Parking in any shoreside spot at the Marina is limited to 72 hours. This includes the shoreside area along Shoshone Drive at F – J Docks. Vehicles that will not be moved for over 72 hours should be parked in the long-term parking spots at the main Marina basin. Temporary permits are available for tenants' guests. These vehicles should be parked in the long-term area.
 - Tenants with boat trailers who use the parking area near the boat launch should have a trailer parking permit decal. Trailers cannot be left without a vehicle attached.
 - Parking permit decals can be picked up from the office. Any questions? See our Staff.
- EV charging stations are up and running. They are located on both sides of the harbormaster's shed. Two chargers are dedicated to quick charge and require you to move your EV after charging has been completed. One hour's grace period is allowed. The other two chargers are for long-term charging. Your vehicle can be parked in those spots for a total of 72 hours. You need to download the Tesla App to use the charging stations.

Upcoming Marina Events:

April 12 - USCG vessel safety inspections & fire extinguisher recertification

Our vessel check schedule still has some appointments available to get your vessel checked by the USCG and you can have your fire extinguishers recertified without an appointment. Check in with the Harbormaster to schedule your appointment and receive a vessel safety checklist packet.

April 18– 20 Shelter Bay Yacht Club Shakedown Cruise to Cape Sante Marina.

A Few Gardening tips for April:

Slugs can be a real problem in spring here in the PNW. A few tricks to try are to use a natural product like Sluggo, place copper tape or crushed eggshells around plants as a physical barrier, or go out at night and mount a "slugnapping" campaign!

Prune back the dead tops of perennials and grasses to make room for new spring growth.

Pull or dig perennial weeds, from buttercup to English ivy to blackberry brambles. The ground is softer, and the weeds are easier to find before other plants emerge to hide them.

Shelter Bay Amateur Radio Club

Calling all HAMSTERS. In 2024, Shelter Bay volunteers set up an amateur radio club. The purpose is to establish emergency radio communications with first responders, emergency management personnel, the fire department, and residents in the event of a major emergency. As electricity may be out and cell sites down, HAM RADIO may be the only method of communication.

The Safety Committee and CERT volunteers have set up a station in the Disaster Assistance Center at the Storage Lot. Now, we need to be ready to use the system when needed. We need volunteers to prepare. 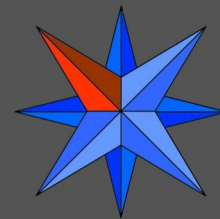
