### Ways to Pay Your Shelter Bay Bills

- **ACH Debit** – Automated Clearing House is an electronic funds transfer system that allows Shelter Bay to automatically withdraw funds from your bank account on the 15<sup>th</sup> of each month to pay your monthly account balance. There is no cost to you for this service. ACH is Shelter Bay's preferred payment method as it is the least costly to both you and the community. Please contact the office for an authorization form if you are interested in this "set it and forget it" option. Additionally, it is the safest of all of the choices to pay your bills.
- **PayLease** – This feature can be accessed via your online account through the Pitera Communications Portal by clicking "Make a Payment" under the Financials tab. You can choose to pay by E-Check, where your bank sends an electronic check on the same day from your bank account. A \$2.95 fee applies to this payment method. You can also choose to pay using a debit/credit card by initiating the payment either as a one-time payment or scheduling recurring payments. There is a \$2.95 fee plus a 3.5% transaction charge for this payment method. If you have not signed up for access, contact the office for instructions. It's easy!
- **Online Bill Pay** – This option is available through your bank's online account. This is not an electronic payment; it is a paper check issued by your bank. Please be aware that bank processing times vary with this method, and it may take up to 10 days for the payment to reach your Shelter Bay account. Plan accordingly!
- **Personal Check** – Shelter Bay will also accept your personal check for bill payment. Manually processing checks is a time-consuming process for staff, whether sent by the member or the member's bank. Remember that increased operating costs impact every member's dues. Personal checks are not a secure method of payment as they contain your bank routing and account number information, as well as your name, address, and sometimes even phone number and driver's license information. With incidents of mail theft increasing, putting a personal check in an envelope, then into your mailbox, then lifting the red flag for the postal carrier, provides an opportunity for someone to use your personal information for nefarious purposes. Payment by personal check is Shelter Bay's least preferred payment method.

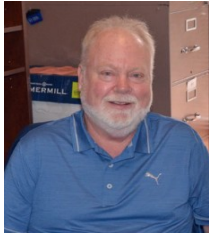
### Safety Committee Members

## Community Manager's Message



**Pool Update** – The pool has been open for a few months, and everything is going well. The sidewalks have now been completed, and we are working on the surrounding bare areas that will be seeded. We will also be upgrading the stairs and installing a wheelchair-accessible ramp. We would like to remind everyone that wristbands are required for each member of your family to use the pool. We have also determined that a few of the umbrellas are not functioning as well as we had hoped, and we are in the process of replacing them. We have also had a couple of instances where some individuals have made a mess in the men's restroom. If you notice the area in disarray, please report it to the pool attendants or the front office so we can address the issue promptly. Thanks in advance for your assistance and enjoy your summer around the pool.

**Playground** — We had an on-site meeting with the Swinomish Planning Department in late June to discuss the project, hoping to get it started. Unfortunately, due to the enlarged wetland buffer, we are still working towards a final solution. We are currently developing a plan that will enable us to install the new equipment in a section of the playground located outside the enlarged buffer area. We are working diligently to complete this task as soon as possible.

**Courts** — The tennis court refresh has been completed and turned out very nicely. The courts were reopened for play on Monday, July 21.

**Marina** – Occupancy remains extremely high, enabling strong financial performance. Derek and Steve continue to tackle various jobs in and around the marina to ensure everything is kept in the best possible condition. The board recently approved the purchase of a new boat to replace our aging and less user-friendly current model. The time from placing the order to completion of the boat is approximately 2 years. Updates will be provided as this moves forward.

**Maintenance Department** – We are pleased to announce that we have hired another staff member, who started on July 21. This new staff member joins us with a water certification, bringing our team to three members who hold this certification. We also have another staff member taking the test to obtain his sewer certification. In addition to the necessary hours required to address both water and sewer issues daily, the maintenance team remains busy working on various issues throughout the community. In late July, the team worked on replacing the waterline anode on the waterline that crosses to Shelter Bay under the channel.

**Roads/Pavement**— We will be sweeping the roads sometime in August and will also be repainting the lines at that time. We will strive to do this more frequently as needed. We are also gearing up for various asphalt repairs now that we are in the new fiscal year. It was brought to our attention that there are a couple of potholes on the outbound side of the main entrance. Our maintenance staff will fix one, and the other is being handled by the Swinomish Planning Department and one of their vendors. We hope to have both addressed very soon.

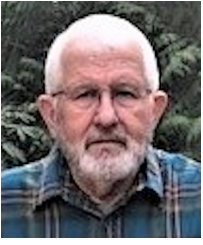
**Coquille Park Building** - The remodel of the old pool building at Coquille Park is nearly complete, and we are currently working on the grounds area surrounding the building. SRC is looking to sponsor a grand opening sometime in late September. Additional information will be shared as plans are finalized.

## Board President's Message



The board started Fiscal Year '26 on July 1 with a Special Meeting to elect officers and approve volunteers to committees. The board voted to elect the same officers as were previously serving: Monte Hicks as President, Rick Parnell as Vice President, Wendy Poulton as Secretary, and Lois Watson as Treasurer. Nancy Shimeall was appointed as Secretary Pro Tem for a third term. I would like to thank the board for all their work, not just at the board level, but also at the committee level. Many of our directors put in more hours as committee representatives than they do as directors, and I don't want to miss this opportunity to thank them. The same gratitude goes out to all our volunteers on the committees. Almost 100% re-upped for this next year, and that says a lot about how dedicated they are to keeping Shelter Bay running so well.

This last year, the board approved an additional \$78,235 for capital projects: sewer plant roof, lift station transfer switches, EV charging stations in the marina tenant parking area, marina rescue ladders, and the Coquille Park remodel. These additional projects continue to add value and maintain our infrastructure as is required by our Master Lease. We have an extensive list of projects for this fiscal year. One of the top priority projects is relocating the water main at Rainbow Park away from the channel to protect our water supply.

The board also established a procedure and guidelines for all bank stabilization and dredging projects, which will be reviewed by the Facilities and Amenities Committee with input from the Harbor Committee as needed. This action will formalize this process, which will be important as Shelter Bay ages, and repairs become more necessary along the waterfront properties.

Lastly, I would like to thank the Lease Negotiating Team for their diligent work toward obtaining a new Master Lease. With their dedication, we are closer than ever to a new lease, and although the process can be painstakingly slow, it is thanks to their weekly commitment over the past four years that we are where we are today. To clarify, we do not yet have a final agreement on the proposed lease structure, but we are close, and hopeful that we will be able to secure a new lease that is in the best interest of all parties.

The board will not convene in August, but we will resume our activities in September with a work session, our annual retreat, and regular meetings.

- 5) Adopted Resolution 25-15 - Safety Committee Guidelines Amendments – General Updates.
- 6) Adopted Resolution 25-16 – Architectural Compliance Guidelines Amendment updating the Appeal Process, so it aligns with Chapter 20 of the Rules and Regulations.
- 7) Adopt Resolution 25-17 – Organizational Chart Updates.
- 8) Approved Social & Rec Committee request to provide New Members Welcome Packets and Gifts and to expense the cost to Operating Supplies.
- 9) Approved Request to Sponsor a Team for the Fire District #13 Annual Golf Tournament Fundraiser.
- 10) Authorized Facilities Committee request for funds to establish a Disc Golf Course within the current Golf Course at a cost not to exceed \$10,000.
- 11) Authorized Harbor Committee to proceed with contracting Munson Boats for a replacement Harbor Boat as recommended (Option 1), for a total of \$181,304, which includes additional allocation of Capital funds for \$1,304.
- 12) Approved Cancellation of the August Board Meeting.
- 13) Approved moving forward with the Termination of Sublease for lots 486 & 498 per the Sublease Agreement through legal.

## **Compliance Corner**

Hey Shelter Bay! It's your local Compliance Officer back with a couple of topics for discussion.

First, I would like to remind the community that we offer Greenbelt Maintenance Permits for those interested. With this permit, you will be allowed to do work in the greenbelts that surround, or are adjacent to, your home. There are some restrictions on what can be done, but I encourage anyone interested to reach out to me or grab an application in the office. These permits are great if you would like to do a little bit of upkeep. For example, many folks mow a greenbelt near their home or use this permit to maintain the work Precision Tree Services completes in the greenbelt.

I have had to request to levy many more fines than usual lately. This is another friendly reminder to familiarize yourself with our Rules & Regulations, so you stay in compliance. I currently receive complaints almost weekly about dogs being off-leash in the neighborhood. This is another reminder that dogs must be leashed and under control at all times in the Community. This is for the safety of yourself, your dog, and other residents around you. Dog-related violations have been abundant this summer, so I would also like to remind the community to minimize their dogs' barking when possible. That said, I'd also like to remind those who complain about dog barking that many dogs bark in reaction to construction and other noisy projects taking place in the community during the day. We all need to do our best to be respectful, understanding, and accommodating neighbors.

Lastly, I thought the community would be interested in the different fines I have levied recently, so I have decided to share them in the newsletters in the future. This month, I have requested fines for dogs being off-leash and not picked up after, trees being cut without permits, and short-term Airbnb listings I have found online.

## Dock Notes



**Communication, communication, communication.** With all the low tides we've been experiencing this summer, the boat launch has been unusable at times. Please take it upon yourselves to check the tides and plan your launching and loading accordingly. Do not use the boat launch on low tides. We have sandbags placed at the bottom of the ramp to prevent erosion. When you launch or load on low tides, it damages the sandbags and accelerates the problem. If you need a spot to park

your boat while waiting for the tide to return, please contact the harbormaster at (360) 333-2952. We will be happy to assist you. Communication is key. We thank you for cooperating with us!

### Parking Lot Reminders

- Vehicles parked overnight at the marina shall display a parking permit decal. Marina parking includes these areas:
  - near the boat launch & A Dock
  - at C/D/E Docks
  - along Shoshone Drive at F-J Docks
- **Parking in any shoreside spot at the marina is limited to 72 hours.** This includes the shoreside area along Shoshone Drive at F-J Docks. Vehicles that will not be moved for over 72 hours shall be parked in the long-term parking spots at the main marina basin. This area is in the middle of the parking lot, encompassing the garden beds. If you are unsure where this area is, please visit the harbormaster for reference.
- **Tenants with boat trailers** who use the parking area near the boat launch should have a trailer parking permit decal. Trailers cannot be left unattached to a vehicle.
- **Parking permit decals** can be picked up from the office. Any questions? See our staff.

**Marina Restroom Roof Replacement:** Starting in early August, Savage Roofing will be replacing the roof of the marina restrooms. Restrooms will remain open during the roof replacement. This is the first stage of renovations for the marina restrooms, and we will continue with interior restoration in the fall.

**Pool Access for Marina Tenants:** Did you know that if you're a tenant of Shelter Bay Marina, you have access to the pool and golf course? Please visit the main office to obtain a wristband and program your SALTO key fob to unlock the pool gate.

**2026 Vessel Registration Stickers:** If you haven't updated your boat registration and attached the new 2026 registration sticker, please do so. We will be conducting an audit this month, and you will receive a reminder. After that, fines will be applied.

**Shelter Bay Yacht Club Friday BBQ:** Friday, August 29, 5:00 p.m. until 7:00 p.m. is our final summer barbecue of 2025. Registration is not required; show up at the Shelter Bay Pavilion, rain or shine. BYOB Happy Hour kicks off at 5:00 p.m.

## Rainbow Bridge Lighting Update July 2025 – Still Working on It!

Rainbow Bridge is the most significant feature of the visual character of the communities of Shelter Bay and the Town of La Conner. For those of us who are privileged to live here, the lighted bridge signifies "Home". The Shelter Bay "Light Brigade" has been formed to fund the permitting, installation, and maintenance of lights on the south side of the bridge in partnership with the Town of La Conner.

A BIG THANK YOU to all our pledge partners! We have exceeded our target of \$13,000. These pledges demonstrate Shelter Bay support in our negotiations with partnering agencies. There may be some minor adjustments to the final contribution as budgets are updated and other conditions discovered. Remember, this project was started 3 years ago! Stay tuned!

**NEXT STEPS:** I am now working with Skagit County (owner of the bridge) to get the permissions and permits required for the project. This will take some time, as agreements with other stakeholders must be negotiated.

I will also be presenting this to the Shelter Bay Board for discussion in the community regarding maintenance cost and "dark sky" issues to hopefully get community approval for the project.

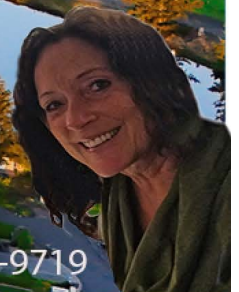


