Budget Development Meetings

Our fiscal year starts on July 1. Now is the time of the year to start developing the budget for Fiscal Year 26-27. The Operating Budget (including Water, Sewer, Lease, and Marina) and then the Capital Improvement Projects Budget is drafted by the Community Manager. The Community Manager will provide the draft budget to the Finance Committee and the Board of Directors by Monday, March 2. In the following weeks, there are three budget development meetings scheduled to review and revise the draft as needed.

March 10 – 12 p.m. – 1:30 p.m. – Operations-Water-Sewer-Marina-Lease

March 17 – 1 p.m. – 2:30 p.m. – Capital Projects

March 24 – 1 p.m. – 2:30 p.m. – Final Review

These meetings will be held in the Clubhouse & via Zoom, and are open to all members of the Community. There will be a Town Hall meeting on April 8 for final Community review and input.

We would appreciate any input you wish to share. Community Manager's Message



Greetings from your Community Manager. I hope 2026 is starting off great for everyone.

We are working diligently on the migration to a new Property Management system and hope to be up and running on the new eUnify system as we move into the month of February. This could change based on when all items are completed in the new system. We plan on running both our current system and the new eUnify system simultaneously for at least one month to ensure everything is synched up. Once we are confident that everything is running smoothly, we will cut over completely and deactivate the current Caliber system. We will provide updates to community members as we begin to make this migration.

I am pleased to announce that we recently hired a part-time staff member to assist with all the ongoing tasks that are overseen by our Architectural Compliance Committee (ACC). Please join me in welcoming Mark Sniffen to our staff. Please see the article by Mike Shannon, ACC chair, for additional details on Mark's background and how he will help streamline the process while ensuring all Shelter Bay guidelines are followed.

Some of you may be wondering what was going on in the pool the third week of January. Part of the original plan was to have a stripe of tile installed on the floor of the pool between the deep and shallow sides. That was not completed during construction, and the pool contractor came back and took care of that. The pool will be refilled before the end of January.

The Maintenance team continues to install drive-by water meter tops, and that portion of the project is 85% complete. They will turn their attention to full meter replacements once the remaining tops are completed. We anticipate starting on the full meter installs in the next month or so dependent upon weather. The use of drive-by meter reads on those that are completed is already saving a lot of time that can be used in other areas. The team has also been doing inspections and some flushing of the water system to identify any items that need to be addressed. This will allow them to schedule any necessary work when we are into warmer weather. We anticipate performing additional flushing of the system sometime this spring.

As always, a big thanks to all the volunteers that work on all the Shelter Bay committees, and on other areas such as the gardens in and around the clubhouse, Annex, Coquille Park, and main entrance.

New Architectural Compliance Officer

Please join me in welcoming Mark Sniffen to our Shelter Bay staff as our new Architectural Compliance Officer. We are glad to have him!



Mark comes to us with years of experience from his previous positions in Whatcom County, Skagit County, and Mount Vernon as a building official, building inspector, and code enforcement officer. He is taking on the role of Architectural Compliance Officer and will work together with the Architectural Compliance Committee in reviewing and approving applications for Certificates of Compliance (CoCs), as well as performing routine in-process and final inspections for matters before the committee.

With this change, Shelter Bay residents will now have a resource to assist them in applying for CoCs for items such as new construction, minor and major remodels, roofing, decking, fencing, site work, lighting, exterior painting, propane tanks and heat pumps, among others. If contemplating work on the exterior of your home, Mark can help with planning your project, providing guidance on CoCs and permitting requirements for compliance with the Swinomish Building Codes.

Our Committee Secretary, Renata McCauley, will continue to be the primary contact for submitting CoCs, and for all matters requiring action by the Architectural Compliance Committee 5 days a week.

Board President's Message



I hope that this finds you relaxing after the hustle and bustle of the holidays and the infamous aftereffect of putting all the holiday decorations away. On behalf of our Compliance Officer, I want to thank everyone for adhering to the January holiday light rules and getting those down in that first week of January.

BUDGET PROCESS: Now that it is February, the board approved the upcoming budget development schedule for the budget work sessions in March (see NL article for dates and times), the Budget Town Hall in April, and the Meet the Candidates Town Hall at the end of April. That said, we are still seeking candidates to run for office. The deadline is March 23 at 5 p.m. to get your application to the office. If you or anyone you know is interested or has any questions about a board position, please reach out and let us know using our board@shelterbay.net email.

The board has approved moving forward with Task Two of the Lally Contract, which initiates the next phase of work to evaluate shoreline erosion along the channel at Rainbow Park and identify effective strategies to mitigate further loss.

This effort represents an important step forward in a long-standing process to develop a durable, broadly supported plan to stabilize the shoreline. Task Two focuses on collecting site-specific data needed to quantify the hydrodynamic forces acting on the shoreline, including the effects of boat traffic, wave action, wind, and water levels. Understanding the magnitude and relative contribution of these forces is essential to accurately identify the causes of erosion.

This data collection phase is expected to take approximately one year and is necessary to properly design, size, and justify an appropriate erosion control solution, rather than relying on assumptions or generalized approaches. The information gathered will be used to evaluate potential mitigation measures and ensure that any recommended solution is both effective and defensible.

Ongoing updates will be provided in the Project Manager's reports included in the board packets each month.

Lastly, be sure to attend a Town Hall the Sunday after each board meeting. This provides residents with the ability to have questions answered by directors in real time. If you send questions ahead of time via the email above, it will provide the opportunity to make certain we are prepared with the most updated information. (Note: emails are not accessed after business hours, weekends, or holidays).

Dock Notes

As we sail into February 2026, the quiet of the off-season offers the perfect opportunity to prepare for the brighter, busier months ahead. While the air may still be crisp, spring is just around the corner, making now the ideal time for maintenance and planning.

Looking for a Fun February Adventure?

Check out the 2026 Seattle Boat Show, January 30 to February 7, at the Lumen Field Event Center and Bell Harbor Marina.



- **Focus on Education:** A major feature is the extensive lineup of over 140 free seminars (106 boating and 38 fishing), along with advanced classes through "Boat Show University."
- **"Boat Show After Dark":** This new evening experience, held on the two Friday nights of the show (January 30 and February 6), features live music, specialty drink stations, and a more social atmosphere.
- **Boats and Exhibitors:** The event, the largest recreational boating show on the West Coast, features hundreds of boats and over 280 exhibitors across two locations: the Lumen Field Event Center and Bell Harbor Marina.

Shore Power Cords: Connections may have loosened at the dock pedestals and at boatside receptacles during recent weather events. Loose connections create resistance which generates heat. Another way resistance occurs between cord and receptacle is through corrosion. Even a bit of saltwater spray on the end of a prong can build up enough corrosion over the winter to create resistance. In the past month we've seen this cause arcing, resulting in burnt receptacles and tripped breakers. If this occurs at the boat end of the cord, it can cause a fire aboard. **Check And Clean Your Cord Ends!**

Water has Been Shut off to All Docks: With overnight freezing temperatures at the end of January, marina staff shut off the dock water to prevent damage to water lines. With freezing temps in our area, it's a good idea to come down and check to make sure your heaters are on and working properly to avoid any damage to your vessel.

- 1) Approved Facilities Committee request for Allocation of Capital Funds to Lally Consulting in the amount of \$225,000 to move forward with Task 2 of the Bank Stabilization Project at Rainbow Park.
- 2) Amended Resolution 24-02 for the Allocation of FY21-22 Retained Earnings/Net Income to correct Section 1 Reserve Fund Balance for Operation Reserves to remain at \$530,072 as no changes were approved to the fund. This was simply a correction of a scrivener's error.
- 3) Approved Manager's Allocation of Funds request to carry over the FY25 Budget remaining funds for Capital Project Meter Reads of \$98,056 and to approve the request for an additional \$36,944 from FY26 Capital Unallocated Funds to complete the project.
- 4) Approved the FY25 Operational Cost Variance Request from Manager Palmer to allow payroll surplus of \$102,206.47 to offset unfavorable variances in the Operating Cost Center leaving a Net Income of \$6,133.

- 6) Accepted the Annual Audit and Consolidated Financial Statements for FYE June 30, 2023, as proposed by accounting firm Williams & Nulle, PLLC.
- 7) Adopted Resolution 26-01 Amending Rules & Regulations Part II, Chapter 20, Committees to incorporate WA State RCW 64.90.445 for meetings and other miscellaneous updates.

- 8) Adopted Resolution 26-02 Amending Rules & Regulations Part II, Chapter 30, Board of Directors to incorporate WA State RCW 64.90.445 for meetings.
- 9) Adopted Resolution 26-03 Allocating certain undesignated Operating Retained Earnings/Net Income to the Operating Reserve Fund.
- 10) Approved Communications Committee Request to Appoint Susan Duffin as Webmaster.
- 11) Approved Social & Rec Committee Request to Sponsor Mahjong Club's weekly use of Coquille Park Building.

Low Sun: That's not a recipe for Chinese noodles! We've enjoyed some beautiful, clear days but there were unexpected hazards. I had no choice two days ago when I came home from Mt Vernon at 3:30 p.m. on Highway 20. The sun was dead ahead, about a foot above the hood, and nearly blinding in heavy traffic. As a retired person with less time constraints, I usually plan my errands in Mt Vernon or Burlington for late morning when the sun is high, to allow myself to return home to Shelter Bay before the sun is low. It is a consideration for those precious clear winter days.

Clear Nights: Clear nights maximize heat radiation from ground to sky. Our early morning sun rises over a landscape which may or not be visibly frosted, but probably has patches of black ice. Be alert to possible slippery spots, whether you are out for a morning walk, or driving. Hiking poles are invaluable for keeping you upright on treacherous ground.


