**Budget Development Meetings**

Our fiscal year starts on July 1. Now is the time of the year to start developing the budget for Fiscal Year 26-27. The Operating Budget (including Water, Sewer, Lease, and Marina) and then the Capital Improvement Projects Budget are drafted by the Community Manager. The Community Manager will provide the draft budget to the Finance Committee and the Board of Directors by Monday, March 2. In the following weeks, there are three budget development meetings scheduled to review and revise the draft as needed.

- March 10 – 12 p.m. – 1:30 p.m. – Operations-Water-Sewer-Marina-Lease
- March 17 – 1 p.m. – 2:30 p.m. – Capital Projects
- March 24 – 1 p.m. – 2:30 p.m. – Final Review

These meetings will be held in the Clubhouse & via Zoom, and are open to all members of the community. There will be a Town Hall meeting on April 8 for final Community review and input.

We would appreciate any input you wish to share. ## Community Manager's Message



Greetings from your Community Manager. Work continues on the migration to the new eUnify property management system. We had hoped to be up and running already but there are still several things that need to be ironed out before we can make the switch. Key members of the SBC team meet multiple times per week with the eUnify team to allow us to complete this as soon as possible. We will provide updates as we get closer.

Last month I mentioned that we hired a new staff member, Mark Sniffen, for the role of Architectural Compliance Officer (ACO). Mark has now been with us for almost two months and has proven he has a strong knowledge base in this area and can oversee many of the duties previously handled by the Architectural Committee (ACC). This would include reviewing submissions from community members for various projects such as new structures, fences, installation of HVAC, replacement of roofing, paint, doing site visits, etc. At the February 18 Board of Directors meeting, the Board approved a motion to have this position handle most of the duties previously overseen by ACC. At the same time, ACC will still be active and involved, but in more of an advisory role, providing guidance and oversight for the ACO. This will be similar to how our Compliance Officer Riley Reynolds and the Green Task Force interact, with Riley now overseeing most of the Green-related items previously overseen by the committee. This change in the ACC process will be a significant benefit to community members, with requests being handled as they are received vs waiting until the next semimonthly ACC meeting. At the same time, the ACO collaborating with the committee will ensure all requests adhere to ACC guidelines and SBC Rules.

Great news! The maintenance team recently finished the installation of all the drive-by water meter tops. This is such a timesaver when it comes to reading meters. They will now start to focus on the full meter replacements, and we hope to have that done over the next three or four months. Another project they will be focusing on is the golf course. Our Maintenance Supervisor is currently establishing a plan for the renovation of the golf course greens, and I have asked him to have this completed by early April.

We look forward to getting the playground equipment project moving forward sometime soon. There are still some permitting issues that need to be completed which should take place in the latter part of February. We also need to move into spring-like weather before we start the project. I will provide updates as we move forward.

## Did You Know? Understanding Shelter Bay's Covenants

### Storage for Recreational Vehicles & Trailers



With the approach of warmer weather comes increased activity with boats and recreational vehicles. Our protective covenants govern the limitations on the storage of recreational vehicles and boats on any lot, tract, or parcel within

Shelter Bay. As stated in the Covenants and Restrictions, Article IV.19, "No trailer, travel trailer, fifth wheel, boat trailer, mobile home, motor home, boat, camper or similar property shall be stored ... for longer than one seven (7) day period, or portion thereof, within any thirty (30) day period, without prior written approval of the committee responsible, unless stored in a garage or carport." This does allow the staging of recreational vehicles or boats on your property for the stated periods of time.



We have been receiving numerous complaints about vehicles excessively exceeding the speed limits in Shelter Bay.

We have been in conversations with the Swinomish Police Department to address this problem. They have graciously agreed to place their speed monitoring system in different locations deemed problem areas in Shelter Bay. The trailer system will flash red and blue lights when the speed limit is exceeded. The system will photograph those vehicles, including license plates, exceeding the designated speed set into the machine. Local law enforcement may pay a visit to the offending vehicles' owners. Let's all commit to a safer community by observing posted speed limits. I want to thank all the residents who honor the speed limits.

The budget process is proceeding on schedule. There will be three consecutive Tuesday afternoon work sessions on the budget, each lasting 90 minutes. ## Grab and Go Kit

This article is in response to residents asking how to prepare a Grab and Go Kit for emergency use.

Everyone should have their own kit (some supplies are for the group). Encourage kids to make their own kits, too, because what's important to them may not be important to you. In the event of a fire or rapid evacuation, you'll appreciate having more than just the clothes on your back.

You should create a kit that you can take with you in an emergency, lasting 2 to 3 days, that's lightweight and easy to carry or tow.

Personally, I use a backpack and a rolling suitcase. Place items in plastic bags to protect against water. Plastic bags used for produce could be a good choice. These can later be used for disposing of waste. Locate these supplies as close as possible to the primary house exit. Consider keeping a kit in your vehicle. Then you will always have supplies with you.

Kit supplies: food, water, flashlight, extra batteries, light sticks, radio (battery/crank), whistle, toiletries and wet wipes, access for important documents, first-aid kit, multi-purpose tool and knife, garbage/plastic bag, cell phone charging cord/extra battery, medications, pet items, duct tape, a set of extra clothes, hat and gloves, items you need for children and other household members. If you create a car kit, add a small shovel, jumper cables, tow chain, road flare, waterproof blanket, matches in a waterproof container, seasonal equipment, and extra keys.

## Dock Notes

Spring is officially on the horizon! Before you hit the water, run through these essentials to ensure your vessel is shipshape and compliant for the season:


- **Systems & Fluids:** Check all engine oil, coolant, and transmission fluid levels. Inspect hoses for cracks or bulges and tighten any loose clamps.
- **Battery Health:** Reinstall fully charged batteries. Clean terminals with a wire brush and apply a light coat of dielectric grease to prevent corrosion.
- **Safety Gear:** Verify that your USCG-required life jackets are in good condition and that your fire extinguishers are not expired or losing pressure.
- **Bilge & Pumps:** Test the bilge pump manually to ensure the float switch activates and that water is actually being discharged.
- **Electronics & Lights:** Power up your VHF radio for a DSC check. Verify that all navigation lights are functioning for those later spring sunsets.
- If your emergency contact card is faded or missing, stop by the harbormaster's office to pick up a new one.
- Please check your shore power cord to make sure it is plugged in all the way into the receptacle.

We have a few maintenance projects starting this March to get the marina in top shape:

- **Garden Beds:** Clearing out the two beds in the middle of the parking lot.
- **Restrooms:** Undergoing restoration work.
- **Docks:** Ongoing pressure washing continues.

We're pushing to get everything wrapped up before the season officially begins!



## Shelter Bay Lookback



**1973 Rainbow Park** was developed. An open house event of Shelter Bay homes benefited a Skagit preschool. Hundreds of people viewed eight homes for \$1 admission. Shelter Bay was on the way to becoming an integral part of Skagit County. There was now a Member Directory. The clubhouse was made more useful and enjoyable by the addition of 100 chairs and 10 tables. The golf tournament became "A Salute to Summer," later known as "Fun Day."


